

Anthony Iannarone—Community Influencer

hile anyone can be a neighbor (it's all about geography), Anthony (Tony) lannarone demonstrates what it's like to be a community influencer. Not only did he make Nutley his home; he made a home out of Nutley. Did that sentence make you ponder? Let's think about that for a moment-when you set up your home, you make the living space not only comfortable but functional.

In a similar way, Tony introduced and implemented changes in Nutley that made many aspects of our community better, more streamlined, and ready to respond to the needs of residents. The dilemma I now have is where to start since his influence has permeated so many areas familiar to all of us.

Let's begin with eighteen-year-old Tony who lost his hands after an explosion in a Rutgers College chemistry laboratory. It was in May, 1949, and "we had finished our work and with nothing to do decided to make a flare," Tony tells us. "The wrong chemicals were used which resulted in an explosion."

Interestingly, after a summer in the hospital, he was back at Rutgers in September and, without losing any time, went on to later graduate Phi Beta Kappa. He was the senior class president and received a Root-Tilden scholarship to New York University School of Law.

He earned Juris Doctor and Master of Laws degrees from NYU and achieved the highest grade on the New Jersey Bar examination. "When I was taking the bar exam, I was cautioned that tests with bad handwriting would not even be graded. We had to use a fountain pen to answer 40 essay questions. Not only was my score the highest, my handwriting was also very legible," Tony said.

He went on to a distinguished law career, most of which was at Hoffmann La Roche where he rose to Associate Vice President and Associate General Counsel.

Along the way, he married Ruth Aitken (who passed away in 2010 after 55 years of marriage). They moved to Nutley in 1959 where they raised Lisa, Brian, and David. "All of our children graduated from Nutley High School," Tony said.

He tells us a little about each of them. "Lisa was a twirler in high school and later graduated Douglass and Seton Hall law school. She is currently a high school teacher. Brian was captain of the track and cross-country teams at high school and has degrees from Albright and Fairleigh Dickinson. David competed in several sports at Nutley High, and was co-captain of the football team along Steven DiGregorio, the current coach. He attended Trinity College and has law degrees from Villanova and Georgetown."

Tony is also very proud of his seven grandchildren.

So, how did an eighteen-year-old student with a serious injury get to be one of Nutley's most accomplished residents? I learned the reason in the course of our discussion after asking him how he became so involved in the town. It seems that whenever he saw an opportunity to make a difference, he entered into the situation wholeheartedly.

"I started by volunteering as a coach for baseball and working with the Boy Scouts; both of these were activities involving my sons," he said.

He also coached midget

basketball and made a noteworthy accomplishment there. "During the off-season, I wrote up the rules for the game. Whether it was a premonition or forward-thinking, I did not use any masculine pronouns, so when the girls' league was started they could still be used."

One of the people who had a major influence on Tony's community involvement was Carmen Orechio, former Commissioner, Mayor of Nutley, and a state senator for eighteen years.

"As Mayor, he appointed me to the **Nutley Public Library** Board in September 1972, and I am still on that board," Tony said. In fact, seven Nutley mayors have appointed him to ten five-year terms as a trustee. He is now serving his 47th year as a trustee and his 33rd year as president of the board. His years as a trustee are longer than any elected or appointed member of any township board in Nutley's history.

Since the library is such an integral part of

our town, it's important to note some of the many accomplishments Tony made there. He was a vital part of the \$2.5 million dollar expansion that redesigned and streamlined the facility on Booth Drive. Nutley was the first Essex County library to join the Bergen County Cooperative Library System (BCCLS) and the library added many technological enhancements as a result of Tony's initiatives. He was also mindful of residents' practical needs and implemented expanded hours and programs for all ages. Additionally,

he has raised more than \$500,000 in permanent gift funds which provides some extra capital each year.

Maria LaBadia, Director of the Nutley Public Library, has high praise for Tony. "I have worked with Mr. I. for the last seven years. His wisdom and knowledge about the Nutley Public Library is astounding. No one has done more for the library than Mr. I. The library is truly his passion."

Tony's influence in town is seen in many other organizations and positions that he held. He served as legal counsel to the Auxiliary Police for 30 years, was a former trustee of the Nutley Family Service Bureau, served on the Clifton Economic Development Commission, and is a founding member of the Friends of the Library, the Dr. Virginius D. Mattia Memorial Committee, and the Nutley Hall of Fame. In addition to his many local awards, he has received the New Jersey State Governor's Jefferson Award in 2013 and the New Jersey Monthly magazine's Garden State Seeds of Hope award. He has also been inducted into the Nutley Hall of Fame.

While Tony lannarone's accomplishments are far too many to list, there is a single theme running through his community involvement: he uses his knowledge and his passion for improvements to better the town of Nutley. Whether serving as a legal advisor, a trustee, or a coach for his sons' teams, he gives full attention to the position and the people and the results are amazing, especially considering his substantial handicap, which he brushes aside as if it didn't exist.

He said, "When someone tells me 'God bless you,' I reply, He already has."

TRUE! The script was written by the writing team of Frances Goodrich and Albert Hackett. Goodrich grew up on Nutley Avenue. Some people think that the famous bridge in the movie was inspired by the one that connects Nutley to Lyndhurst.

TRUE OR FALSE?

The first Indianapolis 500 was held in Nutley. FALSE! However, bicycle races were held at the now-defunct Nutley Velodrome that was

located near Washington Avenue. Later on, midget car races were held at the track.

Matthew's Journey: A Story of Electronics Addiction and Recovery

y 9-year-old son, Matthew, is an addict. Matthew is addicted to video games and electronics. And although it might not sound like a big deal, it is.

On Super Bowl Sunday, I allowed my son to binge play on his iPad so I could watch the game without being disturbed. He was out of my hair, quiet and happy, so why not? What happened after that is why I will never allow that to happen

My son has ADHD, which is difficult to manage on a regular day. Throw in an overdose of electronics and it's is a recipe for disaster. After the Super Bowl ended and his gaming session was over, he could not get himself to sleep. This is something that had never been an issue before. He was so over stimulated that he was unable to regulate his body, behavior, and mood, which caused him to be nasty, irritable and downright miserable. The next two days were an absolute nightmare, not only because I did not allow him to play video games during this time, but really because he was coming down

Rewind to the week prior. I took my son to see a presentation called Digitally Distracted by Thomas Kersting, about the negative effects that electronics have on the brain. During the presentation, Mr. Kersting listed warning signs of your child having an addiction: loses track of time when on electronics; becomes agitated when interrupted; prefers to spend time using electronics rather than playing; does not follow time limits; loss of interest in other activities; seems

from the negative effects of binge playing. He was truly

having symptoms of addiction withdrawal.

restless when not using a device and preoccupied with getting back on; avoids homework and chores because of spending too much time with electronics; sneaks a device when no one is around and lies about it.

I was like a lot of parents when it comes to video games. I didn't believe I was permissive or overindulgent with electronics. I set boundaries. I was that mom that only allowed video games on the weekends, and maybe, if he earned it, an hour a day after school. But, when I looked at things honestly, it was much more.

But, after sitting through that presentation, and then seeing the very real world consequences come to life with my son, I knew we had to make some serious changes, but

I was a little lost as to even where or how to start this detox plan.

Luckily, because of Matthew's ADHD, we already had a relationship with Dr. Lori, Matthew's cognitive behavior therapist. "If he was addicted to drugs or alcohol, would you still let him have just a little bit?" she asked. At that moment, I truly understood that this was a real addiction, just like any other, and decided to completely cut Matthew off from all of his electronics cold turkey.

The first week was absolute torture; Matthew was very angry.

His emotions transitioned to sadness during the second week, to be replaced by acceptance in week three. He began to admit to people that he was in a video game detox. Family members started taking notice that he was more present and conversational. He has not had access to video games or electronics for six weeks now.

Because of his addiction, electronics limitations have been placed on our entire family (my husband, myself, and Matthew's two older sisters). But rather than being resentful, the bond that this has created for us has enriched all our lives. When we go out for dinner, instead of looking at

our phones we talk to each other and find things to laugh about. If there is a lull in the conversation, we play cards or Spot It while we wait for our food. Board games are an everyday occurrence in our house now. We are happier and more socially connected to each other, and we enjoy each other's company so much more.

Will I be able to keep electronics away from him forever? I realistically know that I cannot. What I hope Matthew does learn from this though is that he can live a fun, happy life without electronics being a priority or a

crutch. Like any addiction, recurrence is very real when surrounded by your vice. I hope that, eventually, Matthew can develop a healthy relationship with his electronics without addiction setting back in.

Electronics addiction is very real, particularly for children and their developing brains. And it can have lifelong repercussions if is not addressed. I hope I wasn't too late helping my son. I also hope that we both have the strength to continue to fight this battle. And I'm sharing our story in hopes that it helps someone else not be too late in helping their child. ■











Memorial Day Movies

his Memorial Day weekend, instead of rushing to the latest blockbuster, watch a movie about the United States military. You may not have heard of all ten of these movies. Some might be classics you haven't watched in a while. What ties them all together is their respect for our military and the sacrifices they've made.

ACT OF VALOR (2012)

There are many movies about modern warfare; this one is original because of its authenticity. As they were planning a story about Navy SEALs, the filmmakers realized that, in order to be as accurate as possible, they would need to use

real-life, active duty SEALs. For some scenes, they even used live ammunition!

BRIDGE ON THE RIVER KWAI (1957)

In a Japanese prison camp during WW2, British prisoners are forced to build a bridge. Eventually, the British colonel (Alec Guinness) agrees, believing the bridge will symbolize British spirit. Meanwhile, Allied forces, led by an American officer (William Holden), are planning to blow up the same bridge.

THE DEER HUNTER (1979)

Starring Robert De Niro, Meryl Streep, and Christopher Walken,

this film follows a group of Pennsylvania friends before, during, and after their tour in Vietnam. As the friendships are tested, the film vividly portrays the cost of war-and those who pay it.

A FEW GOOD MEN (1992)

If you want less violence, try this courtroom drama. Tom Cruise and Demi Moore play military lawyers assigned to defend two Marines charged with accidently killing a fellow Marine. At the center of the trial is an intimidating colonel (Jack Nicholson).

FULL METAL JACKET (1987)

While the second half deals with the hero's time in Vietnam, it's the first half, centered on his time in basic training, that earned the film its reputation. Vincent D'Onofrio is brilliant as the unstable "Gomer Pyle," and real-life veteran R. Lee Ermey is unforgettable as a verbally brutal drill instructor.

GLORY (1989)

This Civil War classic centers on the Union Army's first African-American unit. Matthew Broderick plays the Union officer tasked with training and leading these inexperienced men-often with subpar resources. The supporting cast includes Morgan Freeman, Cary Elwes, and Denzel Washington (who won his first Oscar for this film).

MOLLY: AN AMERICAN GIRL ON THE HOME FRONT (2006)

In 1943, an Illinois girl's life is shaken when her doctor father enlists in WW2 and her mother takes a factory job. The family

also takes in a British girl who has come to America to escape the London bombings. With no violence onscreen, this is an ideal choice for families with younger viewers.

THE PATRIOT (2000)

In 1776, fictional colonist Benjamin Martin (Mel Gibson) wants to live in peace with his children. But when his idealistic son (Heath Ledger) joins the Revolution, Martin is forced to take action. A sadistic British officer (Jason Isaacs) provides most of the conflict. The drama is intense, and the violence is not for the faint of heart.

SAINTS AND SOLDIERS (2003)

In Belgium during WW2, four U.S. soldiers (and a British pilot) struggle to cross Allied lines and deliver crucial intel. Produced for under \$1 million, this film took inspiration from real events (like Battle of the Bulge and the Malmedy massacre). To keep costs down, the filmmakers asked WW2 collectors and reenactors to supply the production with authentic uniforms and vehicles.

SAVING PRIVATE RYAN (1998)

Set during D-Day and immediately after, this is already a classic. It follows a squad of Americans as they go behind enemy lines to find a young soldier whose three brothers have already been killed in action. With a cast that includes Tom Hanks, Matt Damon, and Vin Diesel, director Steven Spielberg brilliantly places the audience inside the battles. ■


Many of the County wrestlers will be back in action next season. The hope is that as Nutley continues to develop, the high school


program will reap the benefits of the multi-tiered system. The future looks very bright as the accolades abound for this young Nutley wrestling program.

ast month we explored the creation of benefit shows by the Nutley Fire Department utilizing the Franklin

Theatre. Back then police and fire pension funds were being developed and were dependent on fundraising events run by the members. 1946 saw the police (NPD) and fire departments (NFD) join forces to raise three thousand dollars for their pension fund. Another stage and screen show would be choreographed.

Patrolman William Wallace. an Irish tenor, announced "The

Sheriff of Redwood Valley" would be shown along with six vaudeville acts. Redwood Valley's rail tunnel construction money is stolen, starring James Craven, Bob Steele, Bill Elliott as Red Ryder, Peggy Stewart, and Nutley's own Robert Blake as Little Beaver.

Lionel Stapleton, father of Vivian Blaine, the actress, will organize the acts. Sammy Moss will act as master of ceremonies. Dorothy Wenzel, Raleigh Personality Girl 1945, sings, dances, and performs acrobatics. The Four Kings with Ray Blum, son of Town Commissioner Joseph Blum, will perform a novelty bicycle act. Johnny Valente performs a musical novelty act. Donnelly and Bob do an old-time circus act followed by Elizabeth and Her Canines, a sixteen-dog act with one dressed as a hobo.

1947 saw another seven-act, two-day event on December seventeenth and eighteenth. Six shows emceed by Patrolman William Wallace included: "Home in Oklahoma," big city editor and small town writer investigate a mysterious death, starring Roy Rogers and the world's smartest horse, Trigger. Dale Evans adds a lot of spunk to the film, and George "Gabby" Hayes provides fun support. It is a good mix of music, action, drama and comedy.

George Milano and his melody singers, Stemming and Styles, perform as The Make Believers, Julia Cummings does Hollywood impressions, Grace Andrews magician, Bancott and Cannon sing society favorites, George and Ruthie Ross along with Bill Graves and Company complete the show. Children will be allowed at the matinees.

Chief Hutch also had a great crew of carpenters in the firehouse that built various educational displays. The Cemetery of Fire Hazards, a blunt approach to fire education, was displayed in the Franklin's lobby and library. Toys were also repaired by the firemen and distributed to needy families. Bundles for Britain, a war relief effort, was



located at Franklin and Vreeland where the Capital Bank now does business. Jim Almoney's mom worked the ticket booth in the early forties and lived just down the street above 553 Franklin Avenue.

The Franklin was owned by the Dodds until the early 1940's when Stanley Warner bought the venue. Many of the big movie moguls took over the local theatres to ensure complete control for new releases and marketing. These variety shows helped people escape from the war and daily pressures while enabling the NFD and NPD to raise money for the cause. We have not been able to locate any pictures from these events. Oh, to have a time machine and attend these shows at the Franklin! ■
